The Monroe County Department of Planning and Development has offered the Land Use Decision-Making Training Program – designed especially for new and returning locally elected and appointed municipal board members – since 1985. The current program consists of a series of four-hour workshops that **satisfy New York State’s four-hour annual training requirement**. Elected officials and municipal staff, agency personnel, planners, attorneys, architects, developers, engineers, landscape architects, surveyors and the general public are invited to attend the program.

This fall we are offering two four-hour workshops. Each workshop will run from **4:30-9:00 PM**. The cost is **\$40.00** and includes dinner.

1. Monday, October 7, 2013: **Housing Affordability**
2. Monday, October 28, 2013: **Transportation Fundamentals**

At the end of the program each attendee will receive a **Certificate of Participation** indicating which workshop(s) they attended. At that time elected officials will receive a report of their board members’ workshop attendance.

The Training Program will be held in the R. Thomas Flynn Campus Center (Building 3) at **Monroe Community College** in Brighton. Detailed location and parking information and a free parking pass will be provided with registration confirmation.
