- Department of Environmental Services has 7 divisions: Pure Waters, Solid Waste & Recycling, Business Services, Fleet Services, GIS & Infrastructure Technology, Engineering & Facilities Management, and Environmental Quality Office.

- Pure Waters: Waste water recovery and treatment. County is divided into districts; however Town of Webster manages their own water treatment and is not part of the Monroe County division. Waste water is treated physically, biologically, and chemically. Environmental laboratory assists in water treatment plant process. Also contracts with state and county for drinking water and beach safety & water quality.
- Solid Waste & Recycling: Includes Mill Seat Landfill & Power Plant, Monroe County Recycling Center and Transfer Station. Eco Park handles hazardous household waste, pharmaceuticals and vape devices, cooking oil/grease, lithium batteries, appliances, fluorescent bulbs, textiles, and waste tires.
- Fleet Services: Manages over 900 Monroe County vehicles.
- GIS & Infrastructure Technology: Countywide mapping support, safety emergency planning and support, asset mapping, and mobile Pure Waters/Public Safety dispatch vehicle.
- Environmental Quality Office: Enforcement agency for any industries that discharge waste into Monroe County water systems. Division also has focus on sustainability and is behind Climate Action Plan. Also includes Stormwater Coalition.

Staff Reports:

• Climate Action Plan in public engagement phase. Reached out to town clerks and supervisors with survey on levels of interest and community action.

 - o Natural Resources Committee: Gathering information and reviewing inventory.
