Re: Memorializing the New York State Office of Children and Family Services to Work With Local Departments of Social Services to Develop a Training Program that Allows for a Training System in Western New York

Honorable Legislators:

The Monroe County Department of Human Services (DHS) assists thousands of residents with difficult and time-sensitive issues that require the help of specialized staff. For years, these staff have been trained and certified locally through the Center for Development of Human Services (CDHS), a partnership between SUNY Buffalo and New York State. CDHS has trained over 480,000 participants across New York State between 2002 and 2017.

However, New York State has recently terminated their partnership with SUNY Buffalo, which will discontinue the local CDHS training program across the State. Counties will no longer have a local location for Social Services staff training that is critical to the success of their state-mandated programs. Staff from the Monroe County Department of Human Services who must receive training will be forced to travel to Albany. A portion of the travel costs will be assumed by the County and its taxpayers, who are already forced to bear the costs of state-mandated programs.

The new travel requirements will result in time away from home, which will make recruitment of staff more difficult. In addition, it is uncertain whether the State is prepared to handle the influx of thousands of staff who must be trained within the required 90 days. Smaller counties and counties who are located even farther away from Albany will experience significant costs and delays that will make it more difficult to deliver these services to their residents. During Monroe County's most recent budget discussions, the increase in travel costs for training was discussed at length. Local training options such as programs at community colleges, existing trainers within county staff, or online training are practical and cost-effective solutions to this forthcoming issue.

Therefore, we urge you to join us in calling on the New York State Office of Children and Family Services to work with local departments of social services that allow for training programs across New York State. Requiring staff to travel to Albany for training threatens the ability of counties to deliver important services to their residents in a timely and effective manner. Monroe County is prepared to work collaboratively with New York State to develop training programs so that counties are not adversely impacted by travel costs and delays.

Memorializing the United States Congress to pass HR 6545, and the United States President to Sign the "Violence Against Women Reauthorization Act of 2018"

Honorable Legislators,

The Violence Against Women Act of 1994 (VAWA) was drafted by Senator Joe Biden and co-written by Congresswoman Louise M. Slaughter to provide funds to investigate and prosecute violent crimes against women and men. It imposed automatic and mandatory restitution on those convicted and allowed civil redress in other cases. This act also established the Office on Violence Against Women within the Department of Justice.

The VAWA came up for reauthorization in September 2018, was extended to December 7 but due to the government shutdown has now expired. Prior to the shutdown, both the House and Senate passed budget agreements that would cover the costs of VAWA programs through February 8, 2019. Forty-six House Republicans sent a letter to House Speaker Paul Ryan and House Majority Leader Kevin McCarthy urging leadership to reauthorize VAWA before it was set to expire. There has been no action by the House leadership to reauthorize.

One in three women and one in four men will experience intimate partner violence within their lifetime, according to the National Coalition Against Domestic Violence (NCDAV). More disturbing, every 98 seconds someone in the U.S. is sexually assaulted, which means that every single day more than 570 people experience sexual violence in this country. Sexual violence is a problem deeply rooted in our culture; an estimated 17,700,000 women have been the victims of rape since 1998; 99 percent of perpetrators of sexual violence are not convicted; and 13 percent of female rape survivors will attempt suicide. Girls between ages 16 and 19 are four times more likely to be victims of rape, attempted rape or sexual assault. Female college students ages 18-24 are three times more likely than women in the general population to experience sexual violence.

The VAWA is the first bi-partisan, federal legislation to address sexual violence as a serious crime. This act is vital to help protect women and bring those who would commit violence against domestic partners to justice. Therefore, we implore our federal representatives and our President to reauthorize the Violence Against Women Act. We ask you to join us in memorializing the United States Congress to pass HR 6545, and the United States President to Sign the "Violence Against Women Reauthorization Act of 2018".

Authorize the Initiation of the Process for Making Additions to Monroe County

**Agricultural Districts** 

Honorable Legislators:

I recommend that Your Honorable Body authorize the initiation of the process for making additions to Monroe County's Agricultural Districts.

Section 303-b of the Agriculture and Markets Law requires Your Honorable Body establish an annual 30-day period during which landowners can submit proposals to include land that is predominantly viable agricultural land within a certified agricultural district. Monroe County would begin this addition process by publishing a general notice to make landowners aware of the 30-day submission period. At the end of the 30-day submission period all requests for inclusion will be referred to the Monroe County Agricultural and Farmland Protection Board (AFPB) for its recommendations. The AFPB then has 30 days to make a recommendation to Your Honorable Body concerning any proposed additions to the certified agricultural districts. Upon receipt of the recommendation, Your Honorable Body must hold a public hearing before taking action to adopt or reject the addition of any parcels to any district. A second referral will be submitted to Your Honorable Body after the report of the AFPB to schedule the public hearing and recommend adoption or rejection of the addition of parcels to any district.

### The specific legislative actions required are:

1. Authorize the Clerk of the Legislature to publish and post notice of the 30-day submission period for requests to include land, which is predominantly viable agricultural land, within certified Monroe County agricultural districts.

2. Direct the Monroe County Agricultural and Farmland Protection Board to prepare and submit a report, within 30-days of the termination of the submission period, with its recommendations as to whether inclusion of each piece of land proposed to be included in the certified agricultural districts a) consists predominantly of viable agricultural land and b) would serve the public interest by assisting in maintaining a viable agricultural industry within the certified agricultural districts.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This initiation of process will have no impact on the revenues or expenditures of the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Authorize a Contract with Florida International University National Forensic Science

Technology Center to Provide a DNA Training Course

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Florida International University National Forensic Science Technology Center (FIU/NFSTC), in the amount of \$39,810, to provide a DNA Training course for five (5) newly hired DNA analysts, online and on-site, for the period of February 13, 2019 through December 13, 2019.

The competitive award of the DNA Backlog Reduction Program will provide funding to address the training of additional Monroe County Crime Laboratory personnel, capacity enhancement to accommodate the additional personnel, succession planning and professional development, and improvement of data management. This program allows the Laboratory to provide more timely services to the region's law enforcement community and judicial system. The Laboratory seeks external assistance to efficiently train and integrate new employees into the current workflow. This will require the outsourcing of DNA training in order to minimize the strain on the existing staff and allow them to focus on casework. Without external assistance, there would be a negative impact on productivity and turnaround time which in turn would cause an increase in the existing backlog. Training that meets the specifications of the Laboratory is available through the FIU/NFSTC.

A Request for Qualifications was issued for this contract with FIU/NFSTC selected as the most qualified to provide this service.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Florida International University National Forensic Science Technology Center, 8285 Bryan Dairy Road, Suite 125, Largo, Florida 33777, to provide a DNA Training course for five (5) newly hired DNA analysts, online and on-site, in the amount of \$39,810, for the period of February 13, 2019 through December 13, 2019.

Funding for this contract is included in the 2019 operating budget of the Department of Public Safety, general fund 9300, funds center 2408040100, Monroe County Crime Laboratory.

This contract is 100% funded by the United States Department of Justice, Office of Justice Programs. No net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that Florida International University does not owe any delinquent Monroe County property taxes.

### Honorable Legislators:

I recommend that Your Honorable Body authorize Monroe County to submit funding applications through Federal and New York State funding assistance programs, including the annual Consolidated Funding Applications (CFA), for various projects in calendar year 2019.

The CFA is an annual submission to request state and federal resources in over thirty (30) grant programs to support projects in the areas of community development, waterfront revitalization, energy, environmental improvements, sustainability, education and workforce development and low-cost financing. Any projects that qualify and are selected for funding will be referred to Your Honorable Body for approval.

The New York State Environmental Facilities Corporation (NYSEFC) provides funding opportunities through several grant programs including the New York State Water Infrastructure Improvements Act and the New York State Intermunicipal Water Infrastructure Grants Program. The grant programs managed by NYSEFC support water quality infrastructure projects for municipalities through replacement or repair of infrastructure or compliance with environmental or public health laws.

The United States Environmental Protection Agency provides funding opportunities through several programs including the Water Infrastructure Finance and Innovation Act to provide long-term, low-cost supplemental loans for water infrastructure.

The specific legislative action required is to authorize the County Executive, or her designee, to submit funding applications through Federal and New York State funding assistance programs for various projects in calendar year 2019.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

No net County support is required in the current Monroe County budget.

#### Honorable Legislators:

I recommend that Your Honorable Body authorize contracts with Steve General Contractor, Inc. in the amount of \$1,381,000, for general construction, Billitier Electric, Inc., in the amount of \$394,300, for electrical construction, Pipitone Enterprises, LLC., in the amount of \$345,700, for the mechanical construction, WYCO Mechanical LLC, in the amount of \$324,140, for plumbing construction, and the Dormitory Authority of the State of New York (DASNY), in the amount of \$310,000, for the Monroe Community College Building 7 - Science Lab Renovation Project.

This project involves renovations to approximately 11,800 square feet of science lab and support space on the first and third floors of MCC Building 7 (Sciences Building) at the Brighton Campus. The project will result in new lab configurations and equipment meeting current teaching modalities. Work will include general mechanical, electrical and plumbing; heating, ventilation and air conditioning and electrical systems including upgrades to fire systems, carbon monoxide detection, tel-data, audio-visual information technology and security systems. The project is scheduled to be complete in time for the fall 2019 semester.

The County will enter into a contract with DASNY in the amount of \$310,000 to coordinate interior design services and to purchase all furniture, fixtures and equipment for the project. DASNY's services would include scheduling, procurement, delivery, installation, training, warranty, enforcement, setup, testing, acceptance and certification.

Services for the Monroe Community Hospital Physical Plant Project

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with LaBella Associates, D.P.C. in the amount of \$374,431, for professional engineering services, for the Monroe Community Hospital Physical Plant Project.

The Hospital campus currently utilizes steam from the Iola cogeneration plant constructed in 2002 for heating and cooling. The existing hospital chiller plant was installed in 1994 and is nearing the end of its useful life. This project includes construction of a new boiler and chiller plant at the hospital to more effectively and efficiently serve the campus, including the County's Westfall Building.

Several consultants were considered, with LaBella Associates, D.P.C. rated the most qualified to provide professional engineering services for this project. LaBella Associates, D.P.C. will provide preliminary design services in the amount of \$374,431.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract with LaBella Associates, D.P.C., 300 State Street, Suite 201, Rochester, New York 14614, in the amount of \$374,431, for professional engineering services, for the Monroe Community Hospital Physical Plant Project, and any amendments necessary to complete the project within the total capital fund(s) appropriation.

#### Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with Villager Construction, Inc., in the amount of \$849,000, for general construction services for the Rochester Pure Waters District's (District) Frank E. Van Lare Wastewater Treatment Plant (FEV WWTP) Secondary Clarifiers Improvements, Phase 1 – Test Clarifier Project.

The District owns, operates and maintains the FEV WWTP located at 1574 Lake Shore Boulevard in the City of Rochester. The FEV WWTP is an activated sludge sewage treatment facility originally constructed in the early 1900's. The secondary clarifier treatment system was added in the early 1970s. The FEV WWTP is currently permitted to treat 135 million gallons per day (MGD) of wastewater flow through full secondary treatment. Following biological treatment, the wastewater is conveyed to six (6), 145' diameter secondary clarifiers to separate and remove solids produced in the biological treatment process prior to the water being disinfected and discharged to Lake Ontario. Phase 1 Improvements will include demolition and replacement of the clarifier mechanism, weirs, troughs, and scum box in one of the six clarifiers as well as repairs to existing control joints in the concrete structure.

The District owns, operates and maintains the FEV WWTP located at 1574 Lake Shore Boulevard in the City of Rochester. The FEV WWTP is an activated sludge sewage treatment facility originally constructed in the early 1900's. The secondary clarifier treatment system was added in the early 1970s. The FEV WWTP is currently permitted to treat 135 million gallons per day (MGD) of wastewater flow through full secondary treatment. Following biological treatment, the wastewater is conveyed to six (6), 145' diameter secondary clarifiers to separate and remove solids produced in the biological treatment process prior to the water being disinfected and discharged to Lake Ontario. Phase 1 Improvements will include demolition and replacement of the clarifier mechanism, weirs, troughs, and scum box in one of the six clarifiers as well as repairs to existing control joints in the concrete structure.

Honorable Legislators:

I recommend that Your Honorable Body amend the 2019-2024 Capital Improvement Program and 2019 Capital Budget to add a project entitled "Records Management System and Automated Field Reporting for Law Enforcement Project" in the amount of \$6,500,000; authorize financing for the project in the amount of \$6,500,000; and authorize a contract with Tyler Technologies, Inc. for a Law Enforcement Records Management and Automated Field Reporting Software System and Services in the amount of \$1,772,420.

The age of the two current Police Record Management Systems from 1997 and 2001 has affected the ability to support the system, meet regulatory requirements and perform general operational functions, including prompt information sharing. Expectations of the new system will be to integrate information such as incident reports, arrests, citations, bookings, mugshots, fingerprints, warrant, case management and field contact into a unified database. All 11 local law enforcement agencies, New York State Parole and Monroe County Probation will utilize the system and various other agencies will be able to share information. The primary benefit will be to provide a uniform method of collecting, storing and retrieving information to allow enhanced situational awareness and operational decisions to effectively and efficiently react and record criminal activity.

Updating the technology will add functionality such as Automated Field Reporting for officers in vehicles to provide operational efficiencies and productivity by minimizing data handling, eliminating duplicate entry and maximizing information sharing. Monroe County anticipates the new system will establish a solid foundation for future state and national reporting and potential regional collaboration.

This project is scheduled to be considered by the Monroe County Planning Board on January 24, 2019.

Honorable Legislators:

I recommend that Your Honorable Body amend the 2019 Capital Budget and Bond Resolution 338 of 2017 to provide an increase in funding for the Purchase and Renovation of CityPlace Project, and authorize contracts with Testa Construction, Inc. in the amount of \$1,685,000, for general construction, Landry Mechanical Contractors, in the amount of \$111,900, for plumbing construction, and in the amount of \$444,000, for mechanical construction and Concord Electrical Corp., in the amount of \$417,000, for electrical construction, for the Purchase and Renovation of CityPlace Project.

This project involves renovation of approximately 17,760 square feet of the first and second floors of the recently purchased CityPlace building to facilitate relocation of the Department of Planning and Development to a prominent location on the first floor facing Main Street. This location will increase accessibility and visibility for the Imagine Monroe initiative to encourage and assist businesses to relocate and expand their presence in Monroe County, with the goal to retain and increase local jobs.

Renovations include office and support space for the Department of Planning and Development and the creation of a Business Center where companies and entrepreneurs can perform research and meet with County staff to discuss the benefits of locating in Monroe County. General renovations of CityPlace were initially estimated at a total project cost of \$2,400,000; however, the current estimated total cost for this specific project, based on bids received for the work, is \$4,100,000. An additional \$1,700,000 in funding is required to complete the project.

The Purchase and Renovation of CityPlace Project, in the amount of \$12,400,000, including \$10,000,000 for the purchase and \$2,400,000 for general renovations, was approved by Your Honorable Body by Resolution 338 of 2017. An increase in funding of \$1,700,000 is required to complete the renovations for a total authorization of \$14,100,000.

#### Honorable Legislators:

I recommend that Your Honorable Body accept two grants from the County of Monroe Industrial Development Agency d/b/a Imagine Monroe Powered By COMIDA (COMIDA), the first in the amount of \$511,000, for the period of January 1, 2018 through December 31, 2018, and the second in the amount of \$471,000, for the period of January 1, 2019 through December 31, 2019, both for economic development activities, staff services and office expenses.

These funds are made available to the Monroe County Department of Planning and Development (MCDPD) to support activities to encourage the growth of jobs and businesses in the County. In addition to providing staff services to COMIDA, the MCDPD conducts a Business Outreach Program, provides financial packaging and technical assistance to businesses and municipalities, coordinates planning and employment and training activities, and provides marketing and data to a wide variety of local businesses. This funding represents an increase of \$40,000 from the funding received in 2017, and return to the 2017 level for 2019.

#### The specific legislative actions required are:

- 1. Authorize the County Executive, or her designee, to accept a \$511,000 grant from, and to execute a contract and any amendments thereto with, the County of Monroe Industrial Development Agency d/b/a Imagine Monroe Powered by COMIDA, for economic development activities, staff services and office expenses, for the period of January 1, 2018 through December 31, 2018.
- Authorize the County Executive, or her designee, to accept a \$471,000 grant from, and to execute a contract and any amendments thereto with, the County of Monroe Industrial Development Agency d/b/a Imagine Monroe Powered by COMIDA, for economic development activities, staff services and office expenses, for the period of January 1, 2019 through December 31, 2019.

- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Funding for the services provided under this contract is included in the 2018 and 2019 operating budgets of the Department of Planning & Development, general fund 9001, funds center 1403010000, Economic Development.
