

COURT DEPUTIES AT MONROE COMMUNITY HOSPITAL

"The Business of Being Sheriff"

While hunting on eBay for historical treasure, I found a "stamp-less envelope" from 1832. The envelope was prepaid by the sender as prior to the United States Post Office issuing stamps in 1847, letters were sent to recipients either prepaid or postage collect. I was fortunate to be the high bidder and acquired this antique. Now, on its face stamp-less envelopes have some collectability, but this one was addressed to Sheriff Ezra Parsons, our fifth Sheriff (b. 1798 – d. 1881). The envelope was actually a Court Order requiring Sheriff Parsons to collect the rather large sum of \$376.71 in funds or goods on behalf of Mr. Otis Loomier.

Sheriff Parsons was to obtain that sum or equal value in goods or lands from Mr. Amos Temple who apparently wronged Mr. Loomier thus winning that judgment.


On the document, in Sheriff Parson's own hand is the notation (paraphrasing) "I can find no goods within my bailiwick" (that can be applied to the judgment). So apparently, Mr. Loomier was out of luck.

This document, as it turns out, is the oldest article in our archives (184 years old).

I was pleased to donate this to our archives and it will soon be on display.
