Upcoming Felony Trials

The **People vs. Shaquille Turner** will continue into next week. This case is being prosecuted by Assistant District Attorney Rachel Clark, Deputy Chief of the Non-Fatal Shooting Taskforce.

The defendant is charged with Attempted Murder in the 2nd Degree, Assault in the 1st Degree, two counts of Criminal Possession of a Weapon in the 2nd Degree, and two counts of Criminal Possession of a Controlled Substance in the 3rd Degree in front of New York State Supreme Court Justice Argento.

September 13 – People vs. Marvin Porter

This case is being prosecuted by Assistant District Attorney Bridge Morgan, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Dollinger.

September 16 – People vs. Kwame Acosta

This case is being prosecuted by Assistant District Attorney Elizabeth Buckley, Chief of the Local Courts Bureau.

The defendant is charged with Murder in the 2nd Degree, Attempted Murder in the 2nd Degree, Assault in the 2nd Degree, Criminal Possession of a Weapon in the 2nd Degree, and Criminal Possession of a Firearm in front of Monroe County Court Judge Randall.

September 16 – People vs. Joel Perez and Jeffrey Moctezuma-Ortiz

This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of Vehicular Crimes Bureau.

The defendants are charged with Criminal Possession of a Weapon in the 2nd Degree. Jeffrey Moctezuma- Ortiz is also charged with Criminal Possession of a Controlled Substance in the 3rd Degree and three counts of Criminally Using Drug Paraphernalia in the 2nd Degree. All charges are in front of Monroe County Court Judge Hahn.

September 16 – People vs. Kelvin Stanford, Jr.

This case is being prosecuted by Assistant District Attorney Kaylee Rizzari, of the Special Victims Unit.

The defendant is charged with four counts of Criminal Possession of a Weapon in the 2nd Degree, two counts of Menacing in the 2nd Degree, Criminal Obstruction of Breathing or Blood Circulation, and Assault in the 3rd Degree in front of New York State Supreme Court Justice Renzi.

September 17 – People vs. Lavaughn Quarles

This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Controlled Substance in the 1st Degree, Criminal Possession of a Controlled Substance in the 2nd Degree, seven counts of Criminal Possession of a Controlled Substance in the 3rd Degree, two counts of Criminal Possession of a Weapon in the 2nd Degree and two counts of Criminally Using Drug Paraphernalia in the 2nd Degree in front of New York State Supreme Court Justice Schiano.

September 23 – People vs. Cristian Gonzalez-Reyes

This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in front of New York State Supreme Court Justice Renzi.

September 23 – People vs. Terry Manuel

This case is being prosecuted by Assistant District Attorney Armando Benitez, of the General Felony Bureau.

The defendant is charged with Tampering With Physical Evidence and Petit Larceny in front New York State Supreme Court Justice Argento.

September 24 – People vs. Keyon Wright

This case is being prosecuted by Assistant District Attorney Monica O'Brien, Deputy Chief of the Local Court Bureau.

The defendant is charged with three counts of Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Moran.

September 24 – People vs. Michael Williams

This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in front of New York State Supreme Court Justice Moran.

September 26 – People vs. Dominique Glenn and Shakeela Lindsey

This case is being prosecuted by Assistant District Attorney Jessica Wagner, of the Special Victims Unit.

The defendants are charged with Murder in the 2nd Degree and two counts of Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Miller.

September 30 – People vs. Findlay Owen

This case is being prosecuted by Assistant District Attorney Rachel Clark, of the Non-Fatal Shooting Taskforce.

The defendant is charged with two counts of Assault in the 1st Degree, three counts of Robbery in the 1st Degree, and four counts of Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Dollinger.

September 30 – People vs. Pharell Davis

This case is being prosecuted by Assistant District Attorney Ryan Mulcahy of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in front of Monroe County Court Judge Randall.

September 30 – People vs. Richard Crowder

This case is being prosecuted by Assistant District Attorney Matthew Schiano, of the Major Felony Bureau.

The defendant is charged with Murder in the 2nd Degree and two counts of Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Hahn.

October 1 – People vs. Marlon Williams

This case is being prosecuted by Assistant District Attorney Kristina Hinkley, of the Special Victims Unit.

The defendant is charged with Murder in the 2nd Degree, four counts of Criminal Possession of a Weapon in the 2nd Degree, Attempted Murder in the 2nd Degree, and Assault in the 1st Degree in front of New York State Supreme Court Justice Moran.

October 7 – People vs. Winston Casilla-Made

This case is being prosecuted by Assistant District Attorney Janna Jehlen, of the Special Victims Unit.

The defendant is charged with Rape in the 2nd Degree, two counts Criminal Sexual Act in the 2nd Degree, and Sexual Abuse in the 1st Degree in front Monroe County Court Judge Randall.

October 7 – People vs. Juan Flores, Jr.

This case is being prosecuted by Assistant District Attorney Kaylee Rizzari, of the Special Victims Unit.

The defendant is charged with Rape in the 1st Degree, Criminal Sexual Act in the 1st Degree, and three counts Sexual Abuse in the 1st Degree in front of New York State Supreme Court Justice Renzi.

October 7 – People vs. Chace Rashad Smith and Timothy Earl Tabron

This case is being prosecuted by Assistant District Attorney Drew Kroft and Assistant District Attorney Mikael Pelkey, both of the Vehicular Crimes Bureau.

The defendants are charged with Manslaughter in the 2nd Degree and Timothy Earl Tabron is also charged with Operator Leave Scene of Incident Resulting in Death in front of New York State Supreme Court Justice Argento.

October 7 – People vs. Eric Leslie

This case is being prosecuted by Assistant District Attorney Michael Harrigan, Chief of the Major Felony Bureau.

The defendant is charged with Murder in the 2nd Degree and four counts of Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Dinolfo.

October 7 – People vs. Argelis Maribal

This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of a Weapon in the 2nd Degree in front of New York State Supreme Court Justice Argento.

October 7 – People vs. Michael Scott, Jr.

This case is being prosecuted by Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau.

The defendant is charged with Murder in the 2nd Degree and Criminal Possession of a Weapon in the 2nd Degree in front New York State Supreme Court Justice Walsh.

October 10 – People vs. Najah Alibraheem

This case is being prosecuted by Assistant District Attorney Kevin Sunderland, of the Special Victims Unit.

The defendant is charged with Use of a Child in a Sexual Performance as a Sexually Motivated Felony, Criminal Sexual Act in the 3rd Degree, Rape in the 3rd Degree, and Endangering the Welfare of a Child in front of New York State Supreme Court Justice Sinclair.

Theodice Parks, Theophilus Parks, and Trevan Simmons Indicted

Thursday, September 12, 2024, a Monroe County grand jury indicted Theodice Parks, Theophilus Parks, and Trevan Simmons for their role in the high-speed motor vehicle crash that killed 92-year-old Thomas Chase.

17-year-old Theodice Parks was indicted by the grand jury on charges of Murder in the 2nd Degree, Aggravated Vehicular Homicide, Manslaughter in the 2nd Degree, Assault in the 1st Degree, two counts of Assault in the 2nd Degree, Aggravated Vehicular Assault, Reckless Endangerment in the 1st Degree, Criminal Possession of Stolen Property in the 3rd Degree, and Driving While Ability Impaired by Drugs.

19-year-old Theophilus Parks was indicted by the grand jury on charges of Assault in the 1st Degree and Criminal Possession of Stolen Property in the 3rd Degree.

19-year-old Trevan Simmons was indicted by the grand jury on charges of Assault in the 1st Degree, Criminal Possession of a Weapon in the 2nd Degree, and Criminal Possession of Stolen Property in the 3rd Degree.

All counts are related to the events before and during the motor-vehicle incident that caused the death of Thomas Chase on August 22, 2024.

The case is being prosecuted by Assistant District Attorney Raymond Benitez, Chief of the Vehicular Crimes Bureau and Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau.

Highlights from the MCDA's Office

51-year-old **Laurice Howard** was convicted by a Monroe County jury of Burglary in the 2nd Degree as a Sexually Motivated Felony and Criminal Trespass in the 2nd Degree. On October 26, 2023, Rochester Police Officers responded to a call at a home on Scrantom Street in the City of Rochester. A man had broken into a house where two young children were sleeping. The mother of the children woke to the commotion and found the man wearing only unzipped pants, laying with her 8-year-old child. She threw the man out of her house before calling the police. Rochester Police Officers identified the assailant as parolee, Laurice Howard. They located him that same day down the street, where he had broken into another woman's house. This case was prosecuted by Senior Assistant District Attorney Janna Jehlen, of the Special Victims Unit. Laurice Howard is scheduled to be sentenced on October 23, 2024 in front of New York State Supreme Court Justice Renzi.

31-year-old **Tyree Bradley** and 43-year-old **Marvin Knight** were convicted by a jury of Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree. Tyree Bradley was also convicted of Criminal Possession of a Controlled Substance in the 3rd Degree and Marvin Knight was also convicted with Driving While Intoxicated. On October 18, 2023, Rochester Police Officers initiated a traffic stop after a vehicle matched a description of a car involved in a nearby shooting. Officers found that the driver of the vehicle, Marvin Knight was intoxicated. The passenger of the vehicle was Tyree Bradley. An illegally possessed firearm and narcotics were found in the vehicle. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau. The defendants will be sentenced on October 21, 2024, by New York State Supreme Court Justice Schiano.

38-year-old **Byron Bell, Jr.** pled guilty to Manslaughter in the 1st Degree for shooting Ja'Hod Snow, resulting in his death on June 27, 2023. Byron Bell located his wife's stolen vehicle, which the victim was driving. The defendant admitted to shooting the victim in the torso. Ja'Hod Snow was transported to Strong Memorial Hospital, where he died from his injuries. This case was investigated by the Rochester Police Department and prosecuted by Special Assistant District Attorney Aliyah Fowler, of the Major Felony Bureau. Byron Bell, Jr. will be sentenced to 15 years in the New York State Department of Corrections plus 5 years of Supervision on November 27, 2024, in front of New York State Supreme Court Justice Renzi.

An indictment was unsealed charging 62-year-old **Wendy Stone** and 24-year-old **Cody Stone** with Concealment of a Human Corpse. Cody Stone's next court date is Tuesday, September 17, 2024, and Wendy Stone's next court date is November 19, 2024, both in front of New York State Justice Sinclair. This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Youth Part/Major Felony Bureau.

Shawanda Green was indicted on Assault in the 1st Degree in relation to a vehicular assault on July 28, 2024. This case is being prosecuted by Assistant District Attorney Drew Kroft, of the Vehicular Crimes Bureau.

George Simone was indicted on Arson in the 3rd Degree in relation to an intentional fire on July 31, 2024. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

Jovon Williams was indicted on Criminal Possession of a Weapon in the 2nd Degree in relation to the illegal possession of a firearm on August 13, 2024. This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

Nasezire Horton and **Quentin Riviere** were indicted on Murder in the 2nd Degree, two counts of Attempted Murder in the 2nd Degree, four counts of Criminal Possession of a Weapon in the 2nd Degree in relation to the homicide of Rukia Issack and the attempted murder of two additional victims. In the same indictment, Nasezire Horton, Quentin Riviere and **Renaldo Napier** were indicted on Criminal Possession of a Controlled Substance in the 3rd Degree. Nasezire Horton was also indicted on an additional count of Criminal Possession of a Controlled Substance in the 3rd Degree and Quentin Riviere was indicted on an additional count of Criminal Possession of a Weapon in the 2nd Degree. This case is being prosecuted by Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce.

Ricky Gamble and **Julious Hannah** were indicted on two counts of Robbery in the 1st Degree and four counts of Robbery in the 2nd Degree in relation to two armed robberies on August 17, 2024. This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Youth Part/Major Felony Bureau.

Marcus Santiago was indicted on Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in relation to the illegal possession of a firearm on August 17, 2024. This case is being prosecuted by Assistant District Attorney Ryan Mulcahy, of the Special Investigations Bureau.

Marquis Hucks was indicted on Robbery in the 1st Degree and Assault in the 2nd Degree in relation to an armed robbery and assault on August 16, 2024. This case is being prosecuted by Assistant District Attorney Aliyah Fowler of the Major Felony Bureau.

Antonio Vazquez was indicted on two counts of Menacing A Police Officer or Peace Officer in relation to the menacing of two Webster Police Officers on August 21, 2024. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

Willie Mayhall was indicted on Burglary in the 2nd Degree, Robbery in the 3rd Degree, four counts of Criminal Mischief in the 4th Degree, and Criminal Obstruction of Breathing or Blood Circulation. This case is being prosecuted by Assistant District Attorney James Nguyen, of the Special Victims Unit.

Sulamain Hawkins and **Anastasia Weaver** were indicted on Manslaughter in the 2nd Degree in relation to the death of Sulamain Hawkins, Jr. This case is being prosecuted by Assistant District Attorney Sara VanStrydonck, of the Special Victims Unit.

Brian Santos was indicted on Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in relation to the possession of an illegal firearm on August 8, 2024. This case is being prosecuted by Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce.

Paolo Smith was indicted on Manslaughter in the 2nd Degree, Vehicular Manslaughter in the 2nd Degree, Criminally Negligent Homicide, Operator Leave Scene of Incident Resulting in Death, and Driving While Intoxicated in relation to the vehicular incident resulting in the death of Lashawnda Leggett on August 1, 2024. This case is being prosecuted by Assistant District Attorney Mikael Pelkey, of the Vehicular Crimes Bureau.

Corina Disteffano and **David Strebber, Jr.** were indicted on Criminal Possession of Stolen Property in the 3rd Degree and Unauthorized Use of a Vehicle in the 3rd Degree in relation to the possession of a stolen vehicle on August 10, 2024. This case is being prosecuted by Assistant District Attorney Armando Benitez, of the General Felony Bureau.

Zayvion Harris was indicted on Criminal Possession of a Weapon in the 2nd Degree in relation to the illegal possession of a firearm on August 10, 2024. This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

Andrew Trammell was indicted on two counts of Predatory Sexual Assault Against a Child, Sexual Abuse in the 1st Degree, two counts of Disseminating Indecent Material to Minors in the 1st Degree, Endangering the Welfare of a Child, Course of Sexual Conduct Against a Child in the 2nd Degree, and Failure to Register or Verify as a Sex Offender. This case is being prosecuted by Assistant District Attorney Kristina Hinkley, of the Special Victims Unit.

Eddie Windom was indicted on Criminal Possession of a Weapon in the 2nd Degree and two counts of Criminal Possession of a Weapon in the 3rd Degree in relation to the illegal possession of a firearm on August 12, 2024. This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

Jeffrey Perez was indicted on Sexual Abuse in the 1st Degree and Endangering the Welfare of a Child in relation to the sexual assault of a child on May 29, 2023. This case is being prosecuted by Assistant District Attorney Kaylee Rizzari, of the Special Victims Unit.

Ezavion Williams was indicted on Criminal Possession of a Weapon in the 2nd Degree in relation to the illegal possession of a firearm on May 12, 2024. This case is being prosecuted by Assistant District Attorney Robin Catalano, Chief of the Special Investigations Bureau.

Tayvren Love and **Kiarren Tawanda Morrell** were indicted on Assault in the 1st Degree and three counts of Assault in the 2nd Degree in relation to the assaults of multiple victims on July 19, 2024. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

Keyona Sanchez was indicted on Assault in the 2nd Degree and Endangering the Welfare of a Child in relation to an assault against a Monroe County Sheriff's Deputy on February 23, 2024. This case is being prosecuted by Assistant District Attorney James Nguyen, of the Special Victims Unit.

Danny Lowry was indicted on two counts of Criminal Possession of a Weapon in the 2nd Degree in relation to the illegal possession of a firearm on July 12, 2024. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

Andrew McCloud was indicted on Criminal Possession of a Weapon in the 2nd Degree, Criminal Possession of a Weapon in the 3rd Degree, and Criminal Possession of a Controlled Substance in the 7th Degree in relation to the illegal possession of a firearm and narcotics on August 23, 2024. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

Justin Porter was indicted on Murder in the 2nd Degree and two counts of Criminal Possession of a Controlled Substance in the 3rd Degree in relation to the stabbing homicide of Brandon Wyand, on August 20, 2024. This case is being prosecuted by Assistant District Attorney Gregory Clark, Chief of the Public Integrity/Economic Crimes Bureau. On an unrelated indictment, Justin Porter was charged with four counts of Criminal Possession of a Controlled Substance in the 3rd Degree, Criminal Possession of Stolen Property in the 3rd Degree, and Unauthorized Use of a Vehicle in the 3rd Degree. This case is being prosecuted by Assistant District Attorney Terance Calcagno.

Kimberly Maurer was indicted on three counts of Burglary in the 1st Degree, two counts of Assault in the 2nd Degree, and Criminal Obstruction of Breathing or Blood Circulation in relation to domestic burglaries and assaults on May 22, 2024. This case is being prosecuted by Assistant District Attorney Kenisha Flowers, of the Special Victims Unit.

Stacie Calloway was indicted on Attempted Robbery in the 2nd Degree, Attempted Burglary in the 2nd Degree, Robbery in the 3rd Degree, Burglary in the 3rd Degree, two counts of Grand Larceny in the 4th Degree, and Criminal Possession of a Controlled Substance in the 7th Degree in relation to a robbery and burglary on August 20, 2024. This case is being prosecuted by Assistant District Attorney Nicholas Reeder, of the General Felony Bureau.

K'Ron Odom was indicted on two counts of Criminal Possession of a Controlled Substance in the 3rd Degree and three counts of Criminally Using Drug Paraphernalia in the 2nd Degree in relation to the possession of illegal narcotics on November 15, 2023. This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau.

Hubert Charles and **Stephen Hines** were indicted on Robbery in the 1st Degree and Robbery in the 2nd Degree in relation to an armed robbery on August 11, 2024. Stephen Hines was also indicted on Burglary in the 3rd Degree and Petit Larceny for previous incidents. This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau.
